WAGGA WAGGA SHOW SOCIETY RULES AND REGULATION 2018

The following are Rules and Regulations to Exhibitors at the Wagga Wagga Show these rules shall be deemed to be part of the Agreement between the Wagga Wagga Show Society and the Exhibitor/Licensee

Trade Exhibitors Agreement

All Exhibitors, who take up space during the Wagga Wagga Show, are deemed to have read and accepted these Rules and Regulations with or without prior notice thereof.

The Wagga Wagga Show Society reserves the right to immediately revoke an Exhibitors Licence for Trade Space and to grant a Licence for the aforesaid exhibit/site's to another applicant/s in the event of the Exhibitor not complying with any of these terms and conditions contained in the Rules and Regulations or failing to pay in full all fees by the due date, in which event any monies paid in respect of aforesaid exhibit site/s by the Exhibitor shall be forfeited to the Wagga Wagga Show Society.

Settlement Of Account

Any Exhibitor, who has **not** settled his account with the Wagga Show Society in full prior to the Show, shall not be permitted to erect a stand or collect their tickets. The Wagga Wagga Show Society reserves the right to reallocate the site without further notice and all monies paid by the Exhibitor shall be forfeited to the Wagga Wagga Show Society.

APPLICATION FOR SPACE

A deposit, being \$150.00 non refundable of the total participating costs (as calculated for the Licence for Commercial Trade Space) shall be paid to the Wagga Wagga Show Society upon lodgement of the Licence. The balance to be paid in full to the Wagga Wagga Show Society by the Fifth day of August 2018.

Exhibiters who fail to comply with this condition are liable to forfeit any right to his/her site.

Rights to Close Stands

The Wagga Wagga Show Society reserve the right to close any stand which displays or sells merchandise banned by the A.S.C. or for which no details have been submitted, or which the Wagga Wagga Show Society representative deems to be in any way unsuitable, or inappropriate to the standing of the Show.

Release of liability

The Wagga Wagga Show Society shall not be liable for any loss of profit or custom incurred by an exhibitor (due to any event beyond the reasonable control of the Wagga Wagga Show Society including lack of public attendance, partial or complete failure of the electricity or water supply, sewerage or storm water services or part thereof on the Wagga Wagga Show Ground, or as a result of which the Exhibitor is prevented or impeded from using the space originally allocated.

Site Liability

Exhibitors shall not, under any circumstances drive over another exhibitor's allocated space.

No water or oil shall be allowed to leak or drain onto an adjacent site, no rubbish shall be allowed to be dumped on another site, and all rubbish shall be removed from site AND GROUND at the end of the agreed period of Rental, if this is rule is not carried out a site may not be issued for the next Show and the bond will be forfeited and all bond monies forfeited will become the property of the Wagga Show Society.

No oil from deep fry tubs shall be dumped the EPA shall be notified and further bookings refused.

Fire Precautions

Exhibitors shall ensure that their stand does not obstruct access to any fire hose, fire hydrant, fixed fire extinguishers or marked exits on or near their sites. Under no circumstances is straw to be used as part of an indoor display without prior written approval from the Wagga Show Society.

The Hall will be open during the following hours of the show.

Friday 7th September 2018 9.00am – 9.00pm Saturday 8th September 2018 9.00am – 9.00pm

Cancellations

In the event of a cancellation or withdrawal from the show by an Exhibitor, for whatever reason, all monies paid to the Wagga Show Society shall be forfeited. In the event that an Exhibitor withdraws from the Show after the final balance payment, the Wagga Show Society MAY grant part refund at its discretion It is agreed between the parties that, if in the sole discretion of the Management Committee or the Chief Executive Officer or some other authorised officer that the Show is to be partially or fully cancelled for any reason whatsoever, the Exhibitor shall not pursue the Wagga Wagga Show Society for the recovery of lost income or damages. This complete bar to an action applies to all headings of Law, whether it is Common Law in Contract or Tort or pursuant to any State, Territorial, or Commonwealth Statute Law. It is acknowledge by the Exhibitor that the Wagga Wagga Show Society has no duty to have a Show in any Particular year and that this Clause operates as a complete defence for the Wagga Wagga Show Society to any such action.

Bond

The-Exhibitor shall pay to the Wagga Wagga Show Society a \$50.00 Bond as a guarantee that their exhibition sites remain operational until 9pm, on the Friday and Saturday evenings of the show also that the operator has conducted him/herself in a controlled manner satisfactory to the Wagga Show Society. Upon application a refund of the Bond, Money will be mailed to Exhibitors who satisfy this criteria by the end of September 2018 if requested on the appropriate form by the exhibitor.

Removal of Exhibits

Dismantling of Exhibits or Stands.

The Exhibitor shall not dismantle exhibitions or permit goods and material to be removed from exhibition sites during the period of the Show without the permission of the Wagga Wagga Show Society or representee of the Society.

No exhibitor shall dismantle his or her stand before 9.00pm Saturday the last day of the Show. Failure to comply shall result in the loss of the Exhibitors 50.00 bond.

Exhibitors are advised to remove their exhibits by 11pm as there will be no security on the doors at the close of the Show and the Wagga Wagga Show Society will take no responsibility for any breaches of the law. The hall will close at 11pm sharp

The Hall will reopen at 9am the next day 9th September 2018 (please note there will be no security the night of the 9th September 2018 or the next day 10th September 2018).
